VENDOR/COOKER RULES AND REGULATIONS

- 1. PARTICIPATION:** Limited Spaces are available. Space Assignments will be set by Event Coordinator.
- 2. EVENT HOURS:** Saturday, June 20, 2009, 10:00 am – 4:00 pm.
- 3. PRICING:** \$50.00 Entry Fee. Cookers will not collect money, all food is payable by tickets only.
- 4. JUDGING:** There will be 10 judges. Every participant must submit one (1) full rack of ribs to the Judging Station by no later than 12:00 pm. Trophies and cash prizes will be given to 1st, 2nd, 3rd places. (1st prize is guaranteed \$100.)
- 5. FOOD PREPARATION:** 50lbs of pork spare ribs will be supplied to each Cooker. You must cook all 50lbs. Meat must be maintained at a temperature of below 40° Fahrenheit prior to cooking and at 140° Fahrenheit or higher after cooking.
- 6. SANITATION:** Gloves must be worn at all times and Cookers must have hand sanitizer.
- 7. SET-UP/TEAR-DOWN:** Set-up is Saturday, June 20th, 2009 at 5:00 am. Tear-Down should be complete by 4:00 pm. Entrants and Booths MUST be ready for operation by 10:00 am.
- 8. ELECTRICITY AND WATER:** No electricity will be available. Full kitchen is available for cleaning purposes only. Electric smokers, holding ovens or containers, or any other devices with heat producing electrical coils are not allowed.
- 9. GARBAGE:** Area shall be left in the same condition in which it was found. Remove **ALL** debris. Operations are to stay within booth space as listed. Any tenant not keeping their leased area clean and presentable, during the entire event, and cleaned-up at the end of the event, will not be asked back next year and may be disqualified from today's event.
- 10. REFUNDS:** Acceptance of the Contract and all fees is a commitment to exhibit at this event. **NO REFUNDS** will be issued.
- 11. INCLEMENT WEATHER:** This festival will be held rain or shine.
- 12. LOSS OR THEFT:** Neither the Bayside Bears Youth Football & Cheerleading Assoc. nor Brevard County Parks & Recreation can assume responsibility for loss due to damage or theft. Tenant is responsible to secure your area at the close of each day.

Bayside Bears Youth Football & Cheerleading Assoc. reserves the right to make reasonable changes in its Rules and Regulations as the need arises at its sole and exclusive discretion and TENANT agrees to abide by the same. Non-Compliance with these Rules and Regulations as may be amended may result in the termination of your contract.
